TERMS AND CONDITIONS

BOOKINGS: To confirm a booking we require a signed copy of this "The Fine Print" along with Security. Tentative bookings not confirmed within (2) two weeks will automatically be made available to other clients. The method we prefer for securing bookings is to record credit card details and hold them against the booking. Nothing is processed on the card unless a cancellation is made with less than 4 weeks notice.

CANCELLATION: In the event that a confirmed booking is cancelled within four (4) or more weeks a 10 % service fee will be charged. For cancellations after this time, a \$1,000 cancellation fee will be charged.

FINAL PAYMENT / NUMBERS: Confirmation of numbers will need to be fixed five (5) working days prior to your booking. After that time the any cancellations will still need to be paid for. The ability to increasing numbers after that date will depend on availability of space and food preparation. An increase in numbers will have to be paid for accordingly.

LIABILITY & DAMAGE:

Clients are financially responsible for any damage sustained to the property or equipment during the function. A cleaning fee of \$300.00 will be incurred if any part of the property is left in an inappropriate manner. Nothing is to be screwed, stapled or other wise adhered to any surface.

d'Arry's Verandah Restaurant & d'Arenberg P/L will not be responsible in any way for prepared food brought on to the premise.

All necessary care will be taken, but d'Arry's Verandah Restaurant and d'Arenberg Winery do not accept responsibility for any loss or damage of goods, or articles prior to, during or after the event.

NOISE: d'Arry's Verandah Restaurant is situated within a residential area, please respect this when vacating the premises. d'Arry's Verandah Restaurant and d'Arenberg Winery has the right to adjust the noise.

It is a condition of our licence that all evening entertainment finishes at 11.30 PM and guests must vacate premises by 12.00 midnight. Additional time will be charged at \$300.00 per hour of part there of.

CONFETTI: Confetti is not permitted at d'Arry's Verandah Restaurant.

CELLAR DOOR AND GROUNDS: Booking an exclusive use day function does not provide exclusive use of d'Arenberg cellar door or grounds.

TIMES: Evening functions can start no earlier than 6.00PM for catering service and 6.30PM for ceremonies and are based on a 12.00 Midnight licence curfew with last drinks served at 11.30 PM to allow 30 mins to vacate the premises.

Day time functions can start at 11.30AM are based on last drinks at 4.30PM for 5.00PM vacation of premises.

If you wish to have an evening function with a ceremony earlier than 6.30PM, both day and evening minimum spend will need to be paid.

Should your guests stay on after the agreed time a surcharge of \$300.00 per hour or part thereof will apply.

LIQUOR LICENSE: It is a condition of our licence that no alcohol be served after 12.00 Midnight. Responsible service of alcohol as stated in the Liquor Licensing Act 1997 will be adhered to at all times. No alcohol will be served to minors. Management reserves the right to refuse service or remove from the premise customers who are under the influence and in our judgment, pose a threat either to themselves or others.

All evening functions are based on a 12.00 midnight license curfew with last drinks served at 11.30 PM allowing 30 minutes to vacate the premises. All day time functions are based on a 5.00PM vacation, with last drinks served at 4.30PM.

Should your guests stay on after the agreed time a surcharge of \$300.00 per hour or part thereof will apply.

MINIMUM AMOUNTS: A minimum amount of \$5000.00 applies for weekend day functions which constitute exclusive use.

A minimum amount of \$3000.00 applies for weekday functions which constitute exclusive use.

A minimum amount of \$3000.00 for weekday evening functions and \$4000.00 for all weekend evening functions which constitute exclusive use.

OPENING HOURS: Public hours at d'Arry's Verandah Restaurant are 7 days lunch from 12.00 Noon until 5.00PM. Annual closure days are Good Friday, Christmas Day and New Years Day.

COST: d'Arry's Verandah Restaurant supplies glassware, crockery, staff, set up and break down, food and drink as per confirmed package for sit down functions of up to 50 and stand up functions of up to 70. Any additional numbers will incur hire costs for the total number. Table cloths are an additional cost to the client.

The client will need to arrange & supply chair covers, candles, flowers or any other decorations at their own cost.

Any additional set up required of d'Arry's Verandah Restaurant e.g.: placement of flowers, t-candles, chair covers or place cards, will incur a set up fee to be negotiated dependant on individual needs.

MENU: The menu will need to be decided no later than 4 weeks prior to the booking and finalised five (5) working days prior the booking. This must include any dietary requirements of guests. The menu will be selected from the current menu at the time. Any variations or tailoring of dishes will need to be negotiated and costed accordingly.

PRICING: Prices are current as at Jan 2009 but may be altered from time to time, with out prior notice as market prices dictate.
